You continue your aggressive and ongoing intentional harassment and  
discriminatory practices and policies against Ms. Morrison by your blatant violation

Supreme Court and prior Court Orders (2) dismissing your last 2 Show Causes

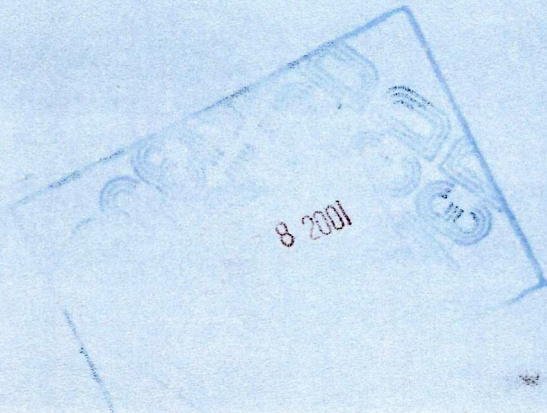
